National Runaway Safeline (NRS) | American Institutes for Research (AIR) | Family and Youth Services Bureau (FYSB)

Each year, millions of young people experience homelessness in the United States. Experiences of homelessness have notable personal and societal costs, so it's imperative that young people facing crises that have or could result in homelessness get access to the resources they need to avert or resolve that crisis.

Recent research found that adverse child experiences (ACEs) may be associated with later experiences of homelessness; among adults who had been homeless, nearly 90% had experienced at least one ACE.

The National Runaway Safeline (NRS)

With the support of the FYSB, NRS serves as the federally designated National Communications System (NCS) for youth in crisis. NRS operates the 1-800-RUNAWAY hotline and live text service in addition to live chat, email, and forum crisis services at 1800RUNAWAY.org. These free, confidential services are available 24/7/365. In addition, among other services, NRS provides free bus tickets to youth looking to reunite with family or travel to alternate living arrangements through its Home Free program, in partnership with Greyhound Lines, Inc.

What is an ACE?

ACEs are events that occur in childhood and adolescence that may have been traumatic. ACEs are typically measured as exposure to violence and neglect, witnessing traumatic incidents, loss of a parent or guardian, or living with someone with mental health or substance use issues. The impact of these experiences can change how individuals respond to stress and have been linked to numerous health conditions.







Prevalence of ACEs Among Focal Youth Under Age 18

NRS collects information that contacts voluntarily share through the course of each crisis intervention, with varying amounts information reported based on what individuals chose to share. This results in different amounts of missing data, ranging from 0% to 78% across the data points analyzed. The percentages and figures listed in this report vary based on the number of individuals who chose to provide information on each data point. In addition, NRS collects "point in time" data, which may lead to an underrepresentation of ACEs.
